

CONSENT FORM

1.I accept all the provisions stated in this waiver and undertake not to make any of them the subject of a lawsuit. I am registering individually for the **Merrell İstanbul Ultra** race and declare that I accept the participation conditions.

2.I undertake to comply with all rules and measures determined by the organization. I acknowledge that I am obliged to follow the instructions of the organizer, race staff, and observers.

3.If the organizer decides that the conditions on race day are unsafe, they have the right to postpone or cancel the race. In the event of postponement or cancellation of the race due to reasons beyond the control of the organization, such as natural disasters, acts of terrorism, state of emergency, strikes, riots, war, epidemic diseases, or decisions made by local authorities, I accept that no refund will be made.

4.I accept that all responsibility regarding my course selection belongs to me and that the organizer cannot be held responsible in this regard. I accept that the organizer is not responsible for any injuries that may occur during activities related to the race.

5.I declare that I made my decision to participate in the race, acknowledging that my health status and physical condition are sufficient. I declare that I will not hold the organizer responsible for any health problems that may occur during the race. It is recommended that people who have been restricted from physical activity by a doctor or who have contraindications to aerobic exertion consult their doctors.

6.I accept that the medical staff has the authority to make decisions regarding me. I accept that the organizer may refer me to a healthcare institution if deemed necessary and that all expenses arising in this case will be borne by me.

7.I accept that if I cause a situation that hinders the progress of the race or endangers the safety of participants, the organizer has the right to disqualify me from the race. I undertake not to leave a participant in need of help alone.

8.I accept that I will not hold the organizer responsible for any material or moral damage I may be exposed to during the race, and that I will be fully responsible for any damage I may cause to third parties or their property.

9.I declare that I will always carry the mandatory equipment with me and allow for inspections.

10.I declare that I will respect the environment and not harm the natural surroundings.

11.I acknowledge and accept that, due to the challenging terrain of the event area, medical response to locations outside of designated checkpoints may be delayed.

I acknowledge and accept that ambulances will be stationed at the start and finish points of the race.

12.I declare and accept that I grant the organizer the rights to use all visual and audio materials related to the event, and that these materials may be used for promotional and marketing purposes.

13.I declare that I do not use substances containing doping.

By signing this document, I accept on behalf of myself, my heirs, administrators, personal and legal representatives that I will not hold the organizers, managers, partners, or those working in the organization responsible for any injury, loss, or damage that may occur during the race or during activities before or after the race. I declare that I have read and accepted the competition rules, that I have no medical obstacle to participating in this race, and that I am physically sufficient.

14.I hereby give my explicit consent, within the scope of my personal rights, for any and all photographs, videos, and audio recordings of me taken during the event to be captured, recorded, copied, processed, published, and shared.

15.I acknowledge and agree that these visual and audio materials may be used without any limitation of time or scope by OLGARLAR SPOR MALZEMELERİ TURİZM İLAN REKLAM AJANSLIĞI YAYINCILIK VE TİC.
